1. **PAYMENT TERMS:** CraveChocolate requires a \$200 deposit in order to reserve a CraveChocolate fountain. To confirm this agreement, return one signed and completed copy of this contract along with the retainer of \$200. Availability is on a first come, first serve basis. Reserve early! The balance is due no later than 10 days prior to the date of the event and can be paid in cash, check, or money order. All Checks should be made payable to CraveChocolate. A \$35 fee will be charged for all returned checks.
2. **CANCELLATION:** If the Client initiates the cancellation the deposit is non-refundable.
3. **PROVISIONS:** CraveChocolate requires access to the desired set-up area at least 60 minutes prior to the scheduled start time. In addition, 60 minutes are required after the conclusion of the service period for take down and removal (this time does not count toward the 2 hours of fountain service time). CraveChocolate (or facility) will provide a sturdy, level table capable of supporting at least 150 lbs. CraveChocolate (or facility) is also responsible for providing table linens. CraveChocolate requires at least one 120 volt circuit within 10 feet of the desired set-up area that adheres to contemporary safety standards and supplies at least 15 amps. Once the chocolate fountain has been set up in the desired location, it cannot be moved during the event. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions. CraveChocolate reserves the rights to use any picture(s) from the event in advertising.
